

- Like health and home insurance, you must sign-up and be approved for crop insurance before a disaster strikes, like coffee leaf rust or an environmental event.
- The deadline for signing-up for the following is Dec. 31
 - Coffee tree and fruit
 - Banana tree

FSA Outreach Updates

The 2018 Farm Bill authorized alternative documentation for heirs' property operators to establish a farm number. A farm number is required to be eligible for many different USDA programs, including lending, disaster relief programs, and participation in county committees. Operators on heirs' property who cannot provide owner verification, or a lease agreement, may provide alternative documents to substantiate they are in general control of the farming operation. **Download the fact shee**t on the Heirs' Property Landowners webpage now - https://bit.ly/3qlpHa4
