## **Worker Protection Standard Webinars - English and Spanish**

Did you know that a farm worker who enters a field (within 30 days of last pesticide application), who handles, and/or applies pesticides, must be WPS trained annually? Many, if not all farms regardless of organic or conventional farming methods, use pesticides if applying a product to kill a beetle, bug, fungus, mite, rat, or weed. Learn how to keep yourself and your workers safe from improper use, storage, handling, application, and disposal of pesticides.

These webinars will cover the current Worker Protection Standard (WPS) provisions and requirements as well as any new rule changes. They are free and open to all agricultural employers, owners, managers, and their employees. Those with RUP licenses can earn 1.0 CEU for attending a (English only) WPS webinar below. If you've attended past WPS webinars (8/11/22; 8/12/22) under course code 3951, you will not be able to receive additional credits under this code.

#### Respirator Fit Testing and Training Workshops - On-farm or at the Kona Extension Office

I have received funding from the Hawaii Department of Agriculture to conduct pesticide safety outreach and as part of these efforts I will be hosting worker protection standard (WPS) and respirator fit test trainings. Thank you, HDOA, Rosemary Gutierrez-Coarite (Maui Extension), and Pepe Miranda for partnering with me!

If you are a pesticide handler and/or applicator and the pesticide label requires the use of a respirator, you must be respirator fit tested annually or when workplace conditions change or a new type of respirator is used.

**BEFORE using a respirator and BEFORE attending a respirator fit test workshop, you MUST first obtain a medical clearance to use a respirator.** Once you receive medical clearance from your doctor to use a respirator, you will need to bring your approved and signed medical clearance to the fit testing workshop. A copy of the clearance will work. You will **NOT** be able to be fit tested without a medical clearance signed by your physician.

According to OSHA, your employer must provide respirators, training, and medical evaluations **at no cost to the employee**. Your employer must also provide a medical evaluation to determine employee's ability to use a respirator, **before fit testing and use**.

To obtain a medical clearance from your primary care physician:

- Make an appointment to see your primary care physician.
- Fill out this questionnaire (<a href="https://bit.ly/3d0LRIR">https://bit.ly/3B4vrAP</a>) and take it with you to your medical appointment. The OSHA medical questionnaire can also be found online <a href="https://bit.ly/3Dek7ol">https://bit.ly/3Dek7ol</a>
- Also, take this medical clearance for respirator use form (<a href="https://bit.ly/3TYb40R">https://bit.ly/3qnLFQJ</a>) to your appointment.

Once signed by your physician, bring the original or a copy of your signed medical clearance for respirator form with you to the respirator fit testing and training workshop.

Your employer can also pay for an online respirator medical evaluation. The cost (as of 7/8/22) is \$30.37 (includes tax) per evaluation at <a href="https://www.respexam.com/default.asp">https://www.respexam.com/default.asp</a>. However, a primary care physician's medical evaluation is recommended over an online medical evaluation because of knowledge of the patient's medical history that can be taken into consideration for the use of a respirator.

#### Fukunaga Rootstock Cherry/Seed Available at the Kona Extension Office

We will have Coffea liberica var. dewevrei 'Fukunaga' berries available for purchase at 20 cents per cherry. If you would like to purchase seeds in bulk the cost is \$50 per pound, about 300 cherries.

Some things to note about these cherries:

• The 'Fukunaga' seeds were collected from trees with identical genetics as the mother tree. This plot is semi-isolated from other C. liberica and C. robusta coffee trees; however, we cannot guarantee that the seeds provided are 100% pure 'Fukunaga' seeds. These F1 seedlings should not be used as mother tree seed stock since we cannot guarantee that cross pollination has not occurred with other coffee trees.

- If you are interested in planting a 'Fukunaga' tree on your property to collect your own seed from, we have TWO trees currently available for \$50 each. First come, first served. Others may be available at a later time and we will let growers know when these trees are ready. We are currently growing the rootstock onto which the mother tree's scion would be grafted. We appreciate your patience as these trees require time to grow.
- 'Fukunaga' seeds have a short shelf life. Plant them as soon as possible after processing and/or drying.
- The 'Fukunaga' cherry are not sorted for CBB. There may be CBB-infested cherry and beans present.

We will fill small orders first in the order we receive them and then remaining seed will be divided among larger orders. Our goal is to provide 'Fukunaga' rootstock seeds to as many interested farmers as possible.

## Kona Coffee Settlement: Claims are Due Before September 17, 2022

Dear Settlement Class Member,

Following the Hearing on June 3, 2022, the Court granted final approval to the new Settlements with The Kroger Co. ("Kroger"), Safeway Inc. and Albertsons Companies Inc. ("Safeway/Albertsons"), and Hawaiian Isles Kona Coffee Co., Ltd. ("HIKC") in the class action *Corker, et al., v. Costco Wholesale Corporation, et al.* Case No 2:19-cv-00290-RSL (W.D. Wash.) You are receiving this reminder notice to inform you that the deadline to submit a claim for the new Settlements is **September 17, 2022**.

If you previously submitted a valid Claim Form for the prior Settlements, or if you have already submitted a Claim Form for the new settlements, you do not need to submit a new Claim Form. The Settlement Administrator will use the information already on file to determine your settlement award.

Regardless of whether or not you previously elected to designate a portion of your settlement payment to a charitable fund for the benefit of the Kona region, you still have an opportunity to make this election for these new Settlements. In order to designate a portion of your settlement payment to a charitable fund for the benefit of the Kona region, please respond to this email and provide the percentage of your settlement payment that you would like to contribute.

If you did not previously submit a Claim Form and you would like to be eligible for a settlement award, you must submit a claim online at <a href="www.KonaCoffeeSettlement.com">www.KonaCoffeeSettlement.com</a> or download the Claim Form from the website and mail the completed form to the address listed on the Claim Form. Your claim must be submitted online or postmarked no later than September 17, 2022.

# **HDOA: Emergency Loans Available to Assist with Axis Deer Impacts in Maui County**

The Hawai'i Department of Agriculture (HDOA) will open an emergency loan program to help farmers and ranchers with the costs associated with the overpopulation of axis deer in the County of Maui (Maui, Moloka'i and Lana'i). At an Aug. 23, 2022 meeting, the Hawai'i Board of Agriculture (Board) approved the emergency loan program request by the Agricultural Loan Division. Applications will be accepted beginning Sept. 1 through Dec. 31, 2022.

#### **USDA Updates Crop Insurance Plans to Broaden Access**

The U.S. Department of Agriculture (USDA) is improving two of its most comprehensive risk management safety net programs, Whole-Farm Revenue Protection (WFRP) and Micro Farm, making them more accessible to America's agricultural producers. This includes doubling the maximum insurable revenue under WFRP, now \$17 million, more than tripling the size of farm operations eligible for Micro Farm, now \$350,000 and reducing paperwork requirements for WFRP.

# <u>Funding Increased; Deadline Extended to Sept. 9 for USDA's Reimbursement Transportation Cost</u> <u>Payment Program</u>

The U.S. Department of Agriculture (USDA) has extended the deadline to Sept. 9 for enrollment in the Reimbursement Transportation Cost Payment Program (RTCP). Available funding for RTCP has been increased to \$3 million for fiscal year 2022.

The Consolidated Appropriations Act of 2022 reauthorized RTCP and allows farmers and ranchers in Alaska, Hawaii and insular areas including the Commonwealth of Puerto Rico, Guam, American Samoa, Commonwealth of the Northern Mariana Islands, Virgin Islands of the United States, Federated States of Micronesia, Republic of the Marshall Islands and Republic of Palau, to recover any costs to transport agricultural commodities or inputs used to produce an agricultural commodity. Nearly \$2 million was issued to 882 producers through the 2021 Reimbursement Transportation Cost Payment (RTCP) program in May 2022.
