Dear Growers and Friends,

#### Do NOT Tank Mix ProBlad Verde with BotaniGard or Mycotrol Products

Researchers at Certis Biological conducted a compatibility test to determine if *Beauveria bassiana* strain GHA (the active ingredient of BotaniGard and Mycotrol products) could be tank mixed with ProBlad Verde, a translaminar fungicide approved for use on coffee for coffee leaf rust (CLR) management. According to their testing, *B. bassiana* viability was reduced by 84%, indicating that these products are **NOT compatible**. If using these products for the control of coffee berry borer (CBB) and CLR, apply each separately.

When sprayed directly onto CBB (<a href="https://bit.ly/3RhfXzA">https://bit.ly/3RhfXzA</a>), live *B. bassiana* spores adhere to the beetle's cuticle or exoskeleton, germinate within 6–9 hours, and penetrate the cuticle within about 24 hours. ProBlad Verde (<a href="https://bit.ly/3Szsq2t">https://bit.ly/3Szsq2t</a>) fungicide works on contact and via leaf tissue absorption and translaminar properties. It is driven by multiple-site modes of action to control fungal diseases within 8 hours of contact.

Hence, and until field research can determine the optimal order and timing of application of each product, consider applying BotaniGard or Mycotrol products at least 24 hours PRIOR to an application of ProBlad Verde OR applying ProBlad Verde at least 8 hours PRIOR to application of a BotaniGard or Mycotrol product.

#### **Spraying for CLR**


As the rains continue in your area, keep on top of your CLR management. Remember that CLR spores need free-water to germinate and then infect coffee leaves, so spray to kill CLR spores before they are able to germinate and cause infection. Once infection occurs, none of the current contact or translaminar fungicides will kill the lesions/spots and so they will continue to produce additional spores. Don't forget to apply for the HDOA Pesticide Subsidy Program (<a href="https://bit.ly/3fb806m">https://bit.ly/3fb806m</a>) to get 50% off the cost of approved BotaniGard, Mycotrol, and CLR fungicide products.

#### **Coffee Fertility and Tree Health**

Fruit maturity and harvest in addition to the effects of defoliation caused by CLR can be stressful for coffee trees. During cherry development, coffee requires greater nitrogen and potassium needs (and especially with higher production) to carry its berries through full maturation and proper ripening. Consider using this opportunity while its still raining, to feed trees that have a heavier load of coffee, and those that have yellowing leaves. Foliar fertilization can also be helpful to get needed nutrients into the leaves quickly. As tree growth slows during the winter, these added nutrients will also help trees recover from the harvest and give coffee trees energy to regrow after pruning. If you aren't sure what nutrients your trees need, submit a leaf and soil sample (https://bit.ly/3RhzNe3).

#### **Floater Coffee Parchment**

Communication with growers indicate a higher (than normal) amount of floater (under-developed bean/seed) parchment in the recent harvest(s). This is likely due to the dry weather we received this winter/early spring when young berries were developing.



Pulping of the last two harvests of our grafted Typica and ungrafted Typica at the Kona Research Station, indicates that our ungrafted, seedling trees had 2.4 to 5.5 times more floater parchment than Typica trees grafted onto *Coffee liberica* rootstock. These trees are about 3 years old, within about 175 feet of each other, unirrigated, and the floaters mentioned do not include CBB-damaged parchment.

For future thought, planting grafted trees and providing irrigation during young berry development may help mitigate the impacts of drought.

#### FREE Banana Bunchy Top Virus Testing of Banana Trees (Hawaii County only)

Cooperative Extension received a grant for equipment to detect the presence of the Banana Bunchy Top Virus (BBTV) in samples of banana plants. The grant was approved by the County of Hawaii to lease a fluorometer to detect the presence of BBTV in samples of banana leaves, to support homeowners and commercial growers through this grant.

During Summer 2022, homeowners in the County of Hawaii can submit one sample for testing at no cost, while supplies last. Commercial growers in the County of Hawaii can submit up to two samples at no cost, while supplies last. For more information email adschilo@hawaii.edu

# New from Benefits.gov: FEMA COVID-19 Funeral Assistance & More

#### Do I Qualify?

You may qualify for FEMA COVID-19 Funeral Assistance (https://bit.ly/3dHsLS3) if:

- You are a U.S. citizen, non-citizen national, or qualified non-citizen.
- The death occurred in the United States, including U.S. territories and the District of Columbia.
- The death was attributed to COVID-19.
- You are responsible for the eligible funeral expenses incurred on or after January 20, 2020.

#### What is Covered?

If determined eligible, you may receive up to \$9,000 per deceased individual whose funeral costs you were responsible for. If you incurred funeral costs for multiple deceased individuals per state, U.S. territory, or the District of Columbia, you may be eligible for a maximum of \$35,500 per application. Some expenses that may be eligible for COVID-19 Funeral Assistance include:

- Funeral services
- Cremation
- Interment
- Costs associated with producing death certificates

- Costs due to local or state government laws or ordinances
- Transportation for up to two people to identify the person who died
- Transfer of remains
- Casket or urn
- Burial plot
- Marker or headstone
- Clergy
- Funeral ceremony
- Funeral home equipment or staff

<u>USDA Seeks Input on New Grant Program to Strengthen Food Supply Chain, Reduce Irregular Migration, and Improve Labor Protections for Farmworkers // September 28-29 - one day for employers and the other for labor unions/farmworkers</u>

**WASHINGTON, September 21, 2022** – The U.S. Department of Agriculture (USDA) is gathering input to help shape a recently announced planned grant program focused on improving the resiliency of our food and agricultural supply chain by addressing labor shortages in agriculture, reducing irregular migration through increased use of legal pathways, and improving labor protections for farmworkers. USDA's Farm Service Agency (FSA) will hold three virtual listening sessions on Sept. 28-29 for the new farm labor stabilization and protection pilot grant program, which the Biden-Harris administration announced earlier this year as part of the Los Angeles Declaration on Migration and Protection.

The grant program will use up to \$65 million in American Rescue Plan Act funding to provide support for agricultural employers in implementing robust labor standards to promote a safe, healthy work environment for both U.S. workers and workers hired from northern Central American countries under the seasonal H-2A visa program.
