Dear Growers and Friends,

Agricultural Theft

Within the last 5 months, agricultural thefts occurred on at least two fruit farms on the Big Island and on several properties on Maui. A lower than usual coffee and avocado crop is expected making these targets as well. Agricultural theft could be considered theft in the second degree and a class C felony. Protect yourself and your fruit or other agricultural commodities, and be aware of the following law which was created to protect farmers.

For the transport and sale of all agricultural commodities exceeding 200 pounds or with a value of at least \$100, the Hawaii Revised Statutes section 145-22 requires that (DL-22) records shall include the following:

- (1) The seller's name, residence address, telephone number, and license plate number of any vehicle used by the seller to deliver the commodity to the place of purchase;
 - (2) The name of the farm owner and address of origin;
 - (3) The name of the buyer or consignee, and destination; and
 - (4) The signature of the seller and, upon sale, the signature of the buyer or consignee.

Sales over \$300 also require the seller to present the buyer with a valid photo ID card or license, issued by a federal or state government agency.

Take precautions to safeguard your fruit and ag commodities and report any thefts or possible thefts to the police. If you would like ideas on how to protect your farm and property from agricultural theft, visit https://bit.ly/3rzRafB

For your safety and those around you, avoid intervening while a crime is in progress and call 911. If a theft has already been committed and for non-emergency situations, call your island's non-emergency number. Once the police arrive, provide them with photographs, videos, written documentation, and serial/identification numbers of stolen items, if possible. The more details and evidence provided, the more it might help the officer make an arrest.

Chapter 145, Part II, Hawaii Revised Statutes

Ownership and Movement of Agricultural Commodities

REQUIRES PROOF OF OWNERSHIP - It's the LAW! (see reverse side)

If you sell <u>any amount</u> of an agricultural commodity that is to be marketed for commercial purposes; or transport agricultural commodities weighing more than 200 pounds or the value is \$100.00 or more, an <u>OWNERSHIP AND MOVEMENT CERTIFICATE</u> is required.

WHAT IS REQUIRED ON THE OWNERSHIP AND MOVEMENT CERTIFICATE?

An Invoice, Receipt, Bill of Lading or similar document can serve the purpose of the certificate, provided that it contains the following information:

- The name, resident address and telephone number of the seller, and the license plate number of the vehicle used to deliver the agricultural commodity to the buyer
- 2. The name of the farm owner and address of origin
- 3. The name of the buyer or consignee and destination
- 4. Signature of the seller and, upon sale, the signature of the buyer or consignee

The buyer or consignee must verify the seller's identity by having the seller present a valid government issued photo identification card or license. If the commodity is valued at \$300.00 or more, the seller shall also provide the buyer with a photocopy of the identification card or license.

No prospective buyer or consignee shall purchase an agricultural commodity if the seller does not provide a copy of the Ownership and Movement Certificate and verification as required, and shall report an attempted sale which does not meet the above requirements to the police.

Two copies of the certificate must accompany the shipment and one copy is to be retained by the person completing the certificate.

The Ownership and Movement Certification requirements DO NOT apply to the retail sale of an agricultural commodity to the final consumer.

WHY IS THIS REQUIRED?

Proof of ownership is the first step in establishing a paper trail to help deter agricultural theft. If an inspector or law enforcement officer has probable cause to believe agricultural commodities are in unlawful possession, the inspector or law enforcement officer may request proof of ownership of the commodities, which could lead to the seizure of agricultural commodities and criminal penalties.

National Agricultural Statistics Service (NASS) Agricultural Labor Survey Announcement - Released September 30, 2022

The USDA's National Agricultural Statistics Service (NASS) will conduct its biannual Agricultural Labor Survey in October. The survey will collect information about hired labor from more than 600 Hawaii farmers and ranchers. NASS will compile, analyze, and publish survey results Nov. 23 in the *Farm Labor* report on the NASS website. Survey recipients who do not respond by Oct. 19 may be contacted by NASS to arrange an interview or sent a reminder email.

In the survey, NASS asks participants to answer a variety of questions about hired farm labor on their operations, including total number of hired farm workers, the total hours worked, and total wages paid for the weeks of July 10-16 and Oct. 9-15, 2022. Survey participants can respond online at agcounts.usda.gov or by mail. On the portal, producers can complete their surveys, access data visualizations and reports of interest, link to other USDA agencies, and more.

\$500 Million to Increase Innovative American-Made Fertilizer Production

MEO Agriculture Micro Grants Program 3.0

The MEO Agriculture Micro Grants Program 3.0 will allow operating farms on Maui, Molokai and Lanai to qualify for grant funds up to \$25,000 that will have a direct impact on the availability of:

- local produce
- local livestock and poultry

and other related products

The application period will be from 10-17-22 to 12-16-22. Applications must be completed and submitted with all required documentation before the deadline in order to be considered for the grant. You may apply online or in person at 99 Mahalani Street, Wailuku, HI, 96793.

MEO will ensure equitable distribution among applicants in Maui, Molokai, and Lana'I, with preference given to socially disadvantaged farming applications such as women and native Hawaiians. Funding priority will also be given to applicants that did not receive previous MEO Agricultural Micro Grant. This micro grant will be exclusively for food-producing farm businesses that operate on less than an aggregate of 12 acres or up to an aggregate of 40 usable acres for livestock within Maui County, and possess a County business or state general excise license for the farming business as of July 1, 2022.
