# Collecting Coffee Samples to Create Isotope Footprint - Help Needed!

### **Stopping Counterfeit Kona, Oritain and You!**

Wednesday, November 16, 2022 at 4pm via Zoom

Counterfeiting has long been the bane of Kona coffee. But the science is catching up to the

criminals. Oritain (<a href="http://bit.ly/30adFT1">http://bit.ly/30adFT1</a>), a multinational ag traceability company, is collecting samples of Hawaiian coffees statewide in order to create an isotope "fingerprint" for each region, where potentially fake Kona can be compared against the real deal. Finally, fraud can be proven on a scientific basis.

KCFA, Oritain's ambassador in Kona, needs your help gathering the samples. We are looking for a little less than one lb (400 grams) of green beans from thirty individual TMK's from around North and South Kona. Parchment is also acceptable. The samples will be shipped to Oritain's New Zealand lab and will be used to create an anonymous database for origin traceability. This database can be used at all levels of the supply chain to prove the origin of coffee sold as Kona.
