This is a final reminder to submit your coffee samples for the HCA Cupping Competition (https://bit.ly/3VhAVBN)!

NOTE: the registration deadline has been extended through this Wednesday, May 3.

The Cupping Competition is the Hawaii Coffee Association's opportunity to honor the work and innovation of Hawaii's coffee growers. The competition provides several benefits including feedback from professional coffee tasters (Licensed Q Graders), expanding market opportunities, and the chance to collaborate, network and celebrate the progression of and improvements in Hawaii-grown coffee.

The Hawaii Coffee Association has again partnered with Pacific Coffee Research (<a href="https://bit.ly/41EWZsB">https://bit.ly/41EWZsB</a>) to administer our 14th annual statewide cupping competition. PCR has

selected a panel of Hawai'i-based licensed Q Graders to assess and score samples using SCA protocol and methodology at their Kona lab.

Registration opens on April 10 at 9 am and closes on May 1 at 4 pm. Entries must be received (not sent in) by May 3. Entry fee is \$100 per entry.

# Kona-Based Coffee Company Wins Two Good Food Awards - Both are Hawaii-grown Coffees

On Friday, April 21st, it was announced that Pacific Coffee Research is a winner for the Good Food Foundation's annual Good Food Awards Coffee Division. They won with their 100% Kona and 100% Ka'ū roasted coffees, grown by Aloha Star Coffee Farms and Wood Valley Coffee Farm, respectively. The awards ceremony took place at Revolution Hall in Portland, Oregon, where Pacific Coffee Research was invited to speak on behalf of the coffee awardees. Pacific Coffee Research (PCR) sourced and roasted these coffees which were rewarded on cup quality and their commitment to ethical business practices. PCR is the first Hawai'i-based company to win in this division and this is the first time a Ka'ū coffee has won a Good Food Award. ## WSARE: Professional + Producer Grant Program Accepting Proposals

This grant program involves an agricultural technical advisor (main applicant) and producers implementing projects to address identified needs in sustainable agriculture. With the collaboration of at least three producers, projects must integrate research and education aiming to advance the three components of sustainable agriculture- environmental, economic, and social- and use innovative educational outreach to disseminate new knowledge to producers and other agricultural stakeholders. It is expected that outcomes of funded projects will result in quantifiable benefits for producers, increase the preservation of the natural and social resources upon which agriculture relies, and be shared with other producers. \$75,000 limit/one-three years in scope.

## Myth Busting FSA's New Revenue-Based Disaster and Pandemic Assistance Programs

In January, we announced two new programs designed to assist producers who experienced revenue losses from 2020 and 2021 natural disasters or the COVID-19 pandemic. These programs are revenue-based and feel a little different from our regular programs, but the goal is to better support farmers.

Both the Emergency Relief Program (ERP - <a href="https://bit.ly/41WkZaq">https://bit.ly/41WkZaq</a>) Phase Two and the Pandemic Assistance Revenue Program (PARP - <a href="https://bit.ly/41ZlwHi">https://bit.ly/41ZlwHi</a>) offer a holistic approach to disaster assistance and provide economic support for producers who bear the financial brunt of circumstances beyond their control.

With the rollout of any new program, there is a learning curve for producers and employees alike. ERP Phase Two and PARP are no exception. To encourage producer participation in these valuable programs, I'm going to do my best to debunk some myths and misconceptions surrounding ERP Phase Two and PARP.

With a June 2, 2023, deadline to apply for both programs, it's important that we clear up confusion about how to apply, what documents are required for participation, insurance requirements and related misinformation making its way across the countryside.
