Coconut Rhinoceros Beetle Grubs Found on Hawaii Island

HONOLULU – Coconut rhinoceros beetle (CRB) grubs have been found at a residence in Waikoloa Village on Hawai'i Island. This is the first discovery of the invasive beetle on the island. On Oct. 11, 2023, the resident found five large grubs (larvae) in a decaying palm tree stump on the property and reported it to the Coconut Rhinoceros Beetle Response Project. Staff from the Hawai'i Department of Agriculture (HDOA) responded to the site and collected the specimens which were sent to a University of Hawai'i laboratory in Honolulu where a DNA-based test was used to identify the grubs as CRB. On Wednesday of this week, the resident reported finding one more grub on the property. No other grubs or adult CRB have been detected so far on Hawai'i Island.

Coffea liberica rootstock seedlings available - Big Island ONLY

These are plants are second generation, open pollinated liberica seedlings. Research has shown variation of coffee root knot nematode tolerance when second generation, open-pollinated seedlings are used as rootstock. Hence, these plants are to be used as rootstock grafting material ONLY and NOT for planting out and harvesting rootstock seed from.

We currently have about 100 large *Coffea liberica* seedlings and 20 racks (98 ct) of younger *C. liberica* seedlings available at the Kona Research Station. The larger seedlings can be used to graft larger (approx. 1/4") mother plant scion materials onto. The smaller seedlings can be used to graft seedling materials onto with the Reyna Method.

For grafting larger scion materials, we have had success with leaving at least 2 leaves below the graft, using a splice graft, and grafting onto the green internode or stem of the rootstock with a scion of similar diameter. We have used electrical tape to bind the scion and rootstock together at the graft union and then parafilm to cover the scion and graft union to reduce drying and transpiration. Photos

Maui Pesticide Disposal Event

Greetings,

My name is Adam Williams, Project Manager for the Hawaii Department of Agriculture's ("HDOA") Pesticide Disposal Program ("PDP"). I am writing to inform you about the upcoming Maui pesticide disposal event to be held on Friday, December 15, 2023 from 8:00am to 3:00pm.

HDOA's PDP offers <u>FREE</u> disposal for up to 250 pounds of canceled, suspended, unwanted, or unlabeled ("CSUU") <u>pesticides</u> per eligible participant. Participants contributing more than 250 pounds of pesticides would need to enter into a separate disposal agreement with the contractor at a reduced payment rate. Please see the attached Accepted-Unaccepted Materials list.

Any agricultural entity, licensed pest control operator, landscape professional, pesticide dealer, and other commercial users of pesticides in the State can participate in the pesticide disposal program. **No enforcement action will be taken** against participants for disposing of CSUU pesticides.

The goal of the PDP is to promote a cleaner and safer Hawaii by reducing the amount of pesticides which could potentially impact human health or the environment. If you are on Maui and need to dispose of pesticides, please participate and help spread the word.

If you are not on Maui, yet, have connections with another business that could benefit from this free pesticide disposal program, please send them this email. We kindly ask for your help to make Maui's pesticide disposal event a success.

<u>Deadline Extended to November 30 to submit documentation for USDA's Reimbursement Transportation Cost Payment Program</u>

USDA has extended the deadline to submit supporting documentation for a timely RTCP application received on Sept. 29, 2023 or prior. Producers have until November 30, 2023 to submit receipts for purchases made in fiscal year 2023. This program helps U.S. farmers and livestock producers outside the 48 contiguous states who are at a competitive disadvantage when transporting agricultural products to market.

USDA Risk Management Agency Fact Sheet

Whole-Farm Revenue Protection (WFRP) provides a risk management safety net for all commodities on the farm under one insurance policy. This insurance plan is tailored for any farm with up to \$17 million in insured revenue, including farms with specialty or organic commodities (both crops and livestock), or

those marketing to local, regional, farm-identity preserved, specialty, or direct markets.

<u>USDA's Conservation Reserve Program Pays More Than \$1.77 Billion to America's Producers in Support of Conservation and Climate-Smart Agriculture</u>

The U.S. Department of Agriculture (USDA) has issued more than \$1.77 billion this year to agricultural producers and landowners through its Conservation Reserve Program (CRP), a critical piece of the Department's efforts to support climate-smart agriculture and forestry on working lands. Right now, CRP's more than 667,000 participants received payments from USDA's Farm Service Agency (FSA) for their voluntary conservation efforts on more than 23 million acres of private land. Since 2021, CRP has grown by 21 percent in terms of acres enrolled, testament to the Biden-Harris administration's program improvement efforts.

USDA also announced \$52.6 million in awards under the Fertilizer Production Expansion Program, which will fund 17 new projects to boost domestic fertilizer manufacturing, support innovative fertilizer technologies, and help lower costs for farmers.

Governor Green Releases \$500,000 for DA BUX Double-Up Program

Governor Josh Green, M.D., has released \$500,000 for the DA BUX Double-Up Program (DA BUX), which doubles recipients' purchasing power for locally grown produce, using their federally funded Supplemental Nutrition Assistance Program (SNAP) benefits.

DA BUX program launched in 2017 and is administered by the Hawai'i Food Basket, Inc. in partnership with the Hawai'i Good Food Alliance. The Food Basket estimates that every dollar spent in the program contributes \$2.10 to the local economy.
